1- Egyptian Patent Office (EGPO)

Historical Background

Egyptian Patent Office (EGPO) was founded in 1951, which function is to issue patents and protect the IP rights of inventors, in application of the Law no. 132 of 1949 on the Patents and Industrial designs and amendment thereof; the IPPR Law no. 82 of 2002.

The Egyptian patent office is one of the most prominent bodies of Egypt. It is crucible of creativities and innovations directed to the world of technology and industry and global market, thus fueling the wheel of economic and industrial development in Egypt.

Due to the importance of this role, Egypt has devoted all its efforts and focused on the support of innovation and creativity and the link of scientific research with the industry via utilizing outputs of researches and technological knowledge derived from the inventions and their industrial applicability for the sake of public benefit and coping with the modern technology revolution.

Accordingly, the Egyptian patent office has undergone different developmental phases since its establishment in 1951. It reaches nowadays the highest level of coping with modern technology under the effect of international treaties and agreements that aim at enhancing the office's efficiency. As a result, the Egyptian patent office has acquired the first rank among the Arab patent offices and becomes on an equal footing with European offices.



Objectives

The Egyptian patent office has been established with the aim of protecting the intellectual property of patents and utility models in Egypt, as well as encouraging invention and innovation in favor of the economic growth.

Tasks

- Proceeding with the required actions for patent and utility models protection
- Filing and examining patent applications and utility models
- Granting both Egyptians and non-Egyptia ns patents for inventions and utility models
- Contributing to develop the citizens' innovation skills
- Supporting industries
- Encouraging specialists in the production and scientific research sector to register their inventions

Introduction

Patent information adds to the value of protection applications. It is the means by which the latest technical information in different fields of science is disseminated. Hence, the Egyptian patent office seeks to build a public database of all published documents, in accordance with the system and executive legislation of patents and utility models.

The statistical report for year 2017 includes the most important information and statistics of protection applications submitted to the Egyptian patent information. It is the starting point for issuing more reports to grasp the attention of those interested.

International Cooperation & International Agreements and relationships

Korean International Cooperation

- On July 3rd, 2016, a cooperation proposal was made and delivered by the Korean side, wherein financing issue will, as indicated, be covered under the Korea-sponsored projects at the Egyptian Ministry of International Cooperation.
- Communication was made with the Ministry of International Cooperation, Asian Sector, inquiring about the legality of cooperation with Korean side. Confirmation on and approval of the Korean partnership/proposed project were collected for the development of the Egyptian Patent Office.
- The whole matter was presented to the President of ASRT on October 13th and January 22nd, 2016, and H.E approved to have a Korean delegation in its visit to



EGYPO, which mission was to make a study on EGYPO's needs in an attempt to cope with Egypt Vision 2030.

- A meeting was held with the officers of the Egyptian Ministry's International Cooperation, Asian Sector, and Korean delegation. Financing EGYPO's proposed project was open to discussion along two visits so as to cope with Egypt 2030 Vision Strategy as follows:

a presentation on the project contents was made, comprising:

- To Set up an informatics mechanism and database for information exchange and dissemination to be useful on the national, regional and global level and raise awareness of intellectual property within the framework of Egypt 2030 Vision Strategy and fulfillment of its goals.
- To convert the full description documents of all respective applications and patents into a researchable electronic form using OCR
- To convert applications into electronic form according to applicable WIPO standards to be easily exchanged with Worldwide patent offices.
- To establish a new platform and program for technical examiners, whereby they are able to examine patent applications via searching full or brief descriptions on all national and international accessible databases.
- To set up a new and separate database for the examination of applications using full description documents shared by EGPO and the IP5 participated states (Korea- China-Japan-European Office-US Office) and made available on the EGYPO's databases.
- To set up machine translation for rendering granted patents and application from Korean, Japanese, English and Chinese languages into Arabic and vice versa for the easier examination of patent applications filed in EGYPO.
- To make a plan for EGYPO-manpower training on IP and IT fields.
- To establish IP panorama in Arabic language for increasing awareness of IP crucial role in all sectors across the country.
- Financial support to provide the machines and equipment required for setting up Disaster Recovery.



- Financial support to bring machines and equipment required for increasing level of safety and protection so as to start Electronically furnishing the registration, payment and follow up procedures for the underlying patents and applications by applicants.
- It was agreed to make the preparations needed for a project of around \$ 3.000,000 budget, one million of which assigned for purchasing the required equipment and essentials for the Disaster Recovery Unit, increasing safety and protection for eregistration, payment and follow up of the applications and automation of the EGPO to be on a paperless system.
- A legal study was prepared and a comparison between Egyptian and Korean Laws in relation to patents was made in order to define the legal prerequisites for the said project.
- EGYPO's needs, including machines, equipment and programs, to achieve the project successfully, were highlighted within a respective study.
- A policy and plan for achieving the aforesaid studies were outlined in consistence with Egypt 2030 Vision Strategy for information and innovations.
- The aforesaid studies were made by a group of EGYPO experts to be presented and discussed with the Korean-side donors in presence of the Asian Sector officers of the Ministry of International Cooperation.
- It was agreed to sign the project draft in an ceremonial event in April, 2017 at the premises of the Egyptian Ministry of International Cooperation in presence of the President of the Academy.
