1. International cooperation, agreements and relations

On 7/5/2018, a memorandum of understanding was signed with the State Intellectual Property Office of the People's Republic of China, stating the following:

- Applying the PPH Program for examining applications between the Egyptian Patent Office (EGPO) and the Chinese Patent Office to facilitate examination procedures for the applications submitted to both said offices, following up with the related decisions thereof and exchanging them between technical examiners

Technical examiners prepare search and examination reports for the applications as per the selection of EGPO as the international search and examination authority.

The Technical Examination Department carries out a quality procedure on the applications submitted under PCT Treaty, as per section 21 of the Procedure Manual, since EGPO has an international authority to search and examine applications.

- Benefiting from the expertise of the Chinese Patent Office in the field of genetic resources to facilitate the examination process of the applications submitted in the said field
- Organizing a training program for the IP staff in EGPO
- Benefiting from the IP strategies applied in the Chinese Patent Office
